I/WE ACKNOWLEDE THAT AN INITIAL DEPOSIT OF \$150.00 WILL BE CHARGED BY THE SAN PASQUAL BAND OF MISSION INDIANS DOMESTIC WATER DISTRICT AUTHORITY TO BE RETAINED FOR THE DURATION OF TENANCY. THIS AMOUNT WILL BE REFUNDED TO ME/US UPON TERMINATION OF TENANCY.

I/WE ACKNOWLEDE THAT AN INITIAL RATE OF \$500.00 SERVICE FEE AND THE CURRENT PRICE OF A WATER METER WILL BE CHARGED BY THE SAN PASQUAL BAND OF MISSION INDIANS DOMESTIC WATER AUTHORITY. THIS FEE IS WAVED FOR RESIDENCES OBTAINING WATER SERVICES THROUGH THE INDIAN HEALTH SERVICES.

IN THE EVENT I/WE FAIL TO MEET ALL CRITERIA, ARE IN-ELIGIBLE FOR OR ARE DENIED WATER SERVICE, THE TOTAL AMOUNT OF \$500.00 WILL BE REFUNDED WITHIN THIRTY (30) DAYS OF DENIAL OF DOMESTIC WATER SERVICE.

I/WE ACKNOWLEDGE THAT I/WE WILL BE CHARGED A MONTHLY BASE FEE AND ELECTRICITY FEE ALONG WITH MY/OUR MONTHLY WATER USAGE. THIS AMOUNT WILL BE DETERMINED BY THE SAN PASQUAL BAND OF MISSION INDIANS DOMESTIC WATER AUTHORITY.

I/WE ACKNOWLEDGE THAT I/WE SHALL PROVIDE, INSTALL MAINTAIN AND REPAIR AT MY/OUR OWN EXPENSE, WATER SERVICE LINES FROM THE WATER METER TO MY RESIDENCE/BUILDING. I/WE ACKNOWLEDGE THAT ALL MATERIAL AND METHODS USED IN THE INSTALLATION OF WATER LINES SHALL BE APPROVED BY THE SAN PASQUAL BAND OF MISSION INDIANS DOMESTIC WATER AUTHORITY.

I/WE AGREE TO EXEXUTE AN EASEMENT IF FEE LAND OR LICENSE IF TRUST LAND FOR WATER SERVICE GRANTING TO THE SAN PASQUAL BAND SUCH USE AND IS ACCESS ASIS REASONABLY NECESSARY FOR THE CONSTRUCTION, OPERATION AND MAINTENANCE OF THE DOMESTIC WATER SYSTEM.

I/WE AGREE TO USE THE WATER PROVIDED IN SUCH A WAY AS TO BE USED IN A BENEFICIAL MANNER. I/WE WILL NOT WASTE WATER. I/WE AGREE NOT TO GIVE AWAY, SELL OR ALLOW THE SALE OF THE WATER PROVIDED TO ME/US. I/WE AGREE TO OBTAIN PRIOR WRITTEN AUTHORIZATION FROM THE SAN PASQUAL BAND OF MISSION INDIANS DOMESTIC WATER DISTRICT AUTHORITY FOR ANY AND ALL CONNCECTIONS, OR ALTERATIONS TO THE DOMESTIC WATER SYSTEM.

I/WE UNDERSTAND THAT I/WE MAY WATER OUR LAWN OR GARDEN PROVIDED THAT SAID GARDEN DOES NOT EXCEED AN AREA OF MORE THAN 210 SQUARE FEET AND THAT THE PRODUCE GROWN IN SAID GARDEN WILL NOT BE SOLD FOR ECONOMIC GAIN. I/WE UNDERSTAND THAT THE WAN PASQUAL BAND OF MISSION INDIANS DOMESTIC WATER DISTRICT AUTHORITY SHALL NOT BE LIABLE FOR UNAVOIDABLE INTERRUPTIONS, SHORTAGES, INSUFFICIENCIES OF WATER SUPPLY OR ANY LOSS OR DAMAGES RESULTING THEREFROM.

I/WE UNDERSTAND THAT ANY BREACH OF THIS AGREEMENT GRANTS THE SAN PASQUAL BAND OF MISSION INDIANS DOMESTIC WATER DISTRICT AUTHORITY THE FULL AUTHORITY TO FINE, TEMPORAILY SUSPEND OR TERMINATE SERVICE.

(PURPLE PIPELINE)

I/WE ACKNOWLEDE THAT AN INITIAL RATE OF \$250.00 SERVICE FEE AND THE CURRENT PRICE OF A WATER METER WILL BE CHARGED BY THE SAN PASQUAL BAND OF MISSION INDIANS DOMESTIC WATER AUTHORITY.

I/WE ACKNOWLEDGE THAT I/WE WILL BE CHARGED A FLAT BASE FEE TO BE DETERMINED BY THE SAN PASQUAL BAND OF MISSION INDIANS DOMESTIC WATER AUTHORITY FOR MY/OUR WATER USAGE THROUGH THE PURPLE PIPELINE METER.

PLEASE NOTE THAT THE WATER USED FOR THE PURLE PIPELINE IS RECYCLED WATER AND NOT TO BE USED FOR HUMAN CONSUMPTION.
